Session 2: Regional approaches to Iran's nuclear program

The Iran nuclear file in 2013: Is Iran's challenge to the discrimination embedded in the non-proliferation regime one that has sympathy in the region? What are the relevant over-riding regional security and proliferation concerns in the region, and what are the differences in perspectives and response amongst the Gulf states? What measures are most likely to be effective in states maintaining their commitments to the NPT? Is there a chance to develop an official cross-Gulf dialogue on nuclear non-proliferation and cooperation over nuclear energy programmes?

Session 4: A WMD-free zone in the Middle East

Prospects for the Helsinki conference: where do things stand? Can Gulf states play a proactive role in persuading the Americans (and thus Israelis) of the importance of this initiative for their security, and giving suitable assurances to achieve engagement? How can ME states apply political leverage without threatening good will necessary for the conference and for the NPT? What has happened to the Gulf nuclear weapon-free zone proposal? What are the realistic ambitions for the conference and the process subsequently in the context of the NPT review process? Is it time to be talking of a treaty, or better to build up the elements of a zone independently? Would a regional FMCT or some other limits to fuel cycle activities be a stage in the process, and can such talks start sooner?
